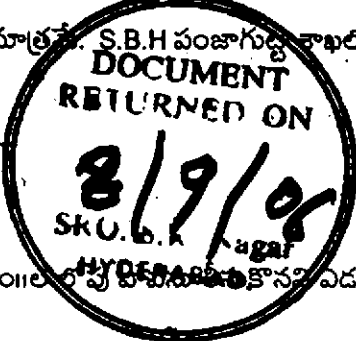

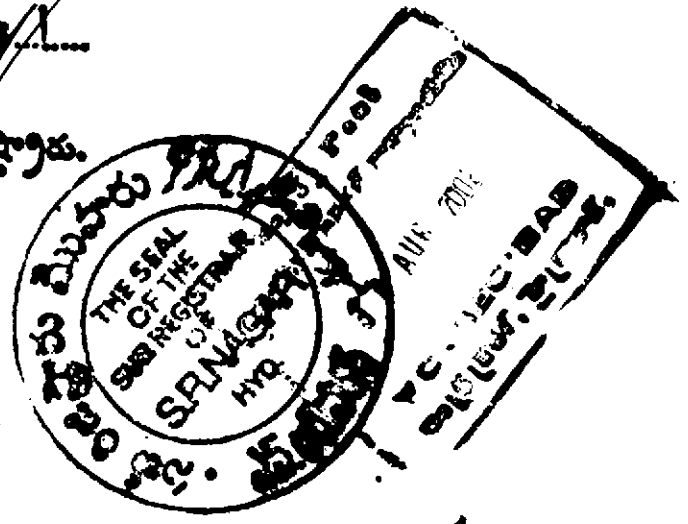

HEREINAFTER CALLED the "AUTHOR/SETTLOR/PRESIDENT" of the trust which expression unless repugnant to the context shall include his successors and assigns ; **AND WHEREAS** THE 'author' / has requested the present trustees mentioned hereunder , to act as trustees of the trust and they have agreed to act so and the 'author' has decided to endorse an initial corpus fund of Rs.10,000/- (rupees ten thousand only), and entrust the same to the trustees to be held


4.OBJECTS OF THE TRUST

The trust has been established for the exclusive benefit of the public for the purpose of:

- a) providing relief to the poor, imparting education in Human Values providing training in life skills generating employment, granting scholarships, providing medical relief and engaging in rural developmental activities.
- b) holding the trust fund on trust exclusively on behalf of and for the benefit of the public in accordance with the terms contained herein;
- c) investing the amounts of the proceeds as procured under the above sub-clause (b), if any, in such investments in accordance with the provisions of this deed;
- d) utilizing the trust fund for the purpose of making any investment in any manner whatsoever, which may include creating an encumbrance of any kind on such part of the trust fund as determined by the settlor;
- e) dealing with the trust fund or entering into any arrangement in relation to the trust fund in such manner as the trustees may consider appropriate; and
- f) such other activities as may be determined by the trustees.

5. DECISIONS OF THE BOARD

The board shall be competent to transact every business of the trust, notwithstanding any vacancy in the board. All the matters relating to the trust and its activities shall be decided by the board after due deliberations and by unanimous decisions to the extent possible and in the event of disagreement on any matter, the opinion of the majority of the trustees shall be binding on all the members of the Board.



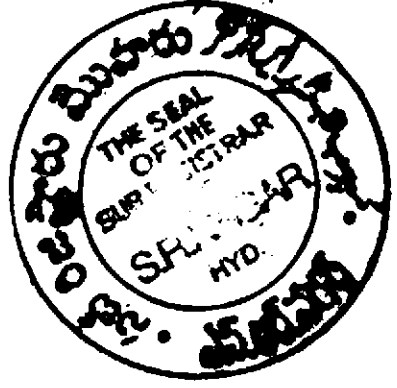

- j) to do all such other acts and things necessary or incidental to carry on the day to day activities/management of the trust, institutions and establishments maintained and / or conducted by the trust.
22. No act of the President or the Secretary requiring the previous sanction of the board shall be invalid merely by reason of the absence of such sanction, if the said act is subsequently ratified by the board.
23. The President, Secretary and other trustees may reimburse themselves or pay or reimburse out of the trust money in their hands, all expenses incurred by them in or about the execution of the trust and / or in the discharge of the duties imposed in them under the trust
24. Any trustee intending to call a meeting of the board shall communicate his intention to the president for convening the meeting, by giving due notice in writing and observe the required formalities for the consideration of any specific subject /s.
25. The quorum for a meeting of the board shall be atleast 5 members physically present in the meeting.
26. The business of the board shall be transacted either at the meetings of the board or by resolutions passed by circulation. The papers containing the resolution by circulation shall be sent to all the trustees and the resolution so circulated shall be deemed to have been passed duly when a majority of the trustees signify their consent in writing
27. Any vacancy in the office of the trustee and / or president and of secretary shall be filled by the Board at its meeting.
28. No act of any trustees shall be deemed to be invalid by reason only of any defect in the appointment or the constitution of the board or any member thereof or on the ground that any member of the board was not entitled to continue in office by reason of any disqualification or by reason of any irregularity in his appointment or by reason of such act having been done or proceedings taken during the period of vacancy in the office of President and/or Secretary or of any other trustee, subject to the ratification by the Board.
29. Subject to the provisions of this deed, the board is hereby authorised to make and prescribe rules and bylaws from time to time for carrying out of the objects of the trust and for administration of the affairs of institutions managed, controlled and or conducted by the trust and all other matters incidental to the working of the trust, and from time to time modify or alter or amend such rules, regulations and bylaws.
30. The investment of funds of the trust are to be made in accordance with the provisions of the section 13(1) (d) read with the section (11) (5) of the Income Tax Act 1961.
31. The income and funds of the trust will be solely utilised towards the objects and no portion of it will be utilised for payment to trustees by way of profit, interest, and dividends etc.
32. Any difference arising in taking any decision by the Board, which is not resolved through discussions among the trustees in the trust meeting, the same may be put to vote and the President will have a casting vote in his capacity, and the decision taken by voting shall be binding on all the trustees.

34. Any amendment of the trust deed will be carried out only with the approval of the Commissioner Of Income Tax / authority granting exemption under the Income Tax Act




35. The benefits of the trust are open to all irrespective of the caste, creed, region, religion, sects etc.


36. The trust will not carry on any activity with the intention of earning profit.
